Photographing the Whitemud Nature Reserve with Wayne Oakes


Wayne Oakes is one of our region's true enthusiasts of natural areas.

1. Welcome, Roll Call

- JoAnne Burek, President called the meeting to order at 7:04pm and requested a roll call.
- Presented a welcome message.
- JoAnne Burek stated she is stepping down from the board.

2. Minutes of AGM April 12, 2019

Motion presented to adopt the minutes of the last AGM. Motion Carried.

3. Audited Financial Statements for Year Ending February 29, 2020

- Financial Statements were presented by Treasurer Sandra Janzen.
- Reviewed bank accounts, general and casino accounts. Stressed the need to engage in fundraising. Membership dues down, due to the trail being closed. This was a unique year and we did not require members to renew their memberships. Big expenses included printing for guidebooks, which were outside budget. No liabilities and overall surplus.
- Motion to adopt financial statements as presented. Carried.

4. Committee Reports

- a. President: JoAnne Burek
 - See separate report.
 - Summary presented included comments that we are much more than a walking club, we have an enthusiastic volunteer force, collective memory, and many events along the trails. Thanks to board members and volunteers.
- b. Membership/ Donations: Cindy Van Volkenburg
 - See separate report.
 - Because of covid and inability to open all trails, we decided to provide free memberships in 2020. We spent time cleaning membership files. As of 2020 there was 120 members; as at Feb 2021 there were 199 members; this represents 70 new members overall and a 54 percent increase. Books sold went from 31 to 56.
- c. Trail Maintenance: reported by Ellen Homola
 - See separate report (photos).
 - We meet on Wednesdays and maintain sections of trails used for hikes. Activities
 include: clearing dead fall, cutting brush, fixing styles, and putting up signs. May to
 Oct work, but this year we started late, in July. Developed a covid safety plan. All
 participants were virus-free. Another challenge this season was that this season was
 wet, causing many changes to schedule. Many plans could not be completed,
 however did complete about 70% of what we did in a normal year. Grateful to
 volunteers and we encourage interested people to become involved.
- d. Permissions: RoseMarie Jalbert
 - See separate report.
 - Presented an overview of leases, contacts made over the phone and in person and reached 121 landowners that allowed the trail to cross their property. There are still 4 landowners to contact. In addition, county and city offices were contacted. This year one landowner refused to cross, and fortunately rerouting was arranged. Reasons for refusal included spousal disagreement.
- e. Trail Locations: Terry Elrod
 - See separate report.
 - Discussed trail locations, construction of trail, styles and boardwalks, bridges.
 Knowing where these are located is helpful when communicating with landowners or in planning trail maintenance. This information is included in the Trail Guide to help locate landmarks. Have documentation for most of the trail. For security reasons, information is not meant for the general membership or public, but rather for landowners and select board members.
- f. Website: Lee Stickles
 - See separate report.

- We maintained the web site, installed plugins, and did not make content change. Focus was on data collection and organization. Since it has been 5 years, we are considering redesign and this is currently being looked into; no formal plans made.
- Resigning from the board. Will keep looking after the website as a member at large.

g. Hikes: Lee Stickles

- When including family members, we have 344 potential attendees for hikes. We arranged 26 hikes last year, vs. 38 prior year. Last year there were other restrictions involving wet weather. Minimal difference in hike attendance. Some concerns with regular guided Sunday hikes due to restrictions; waiting for recommendations from the province. Seeking hike leaders.

h. Beyond Events: Anita Piebiak

- With pandemic, it has been difficult to plan anything. Was looking at organizing a hike to Europe, however it did not proceed. Other discussion about future possible plans.

 role is accepted, at which point a break from the board is necessary. Have flexibility
 to elect more directors at large.

Trail Maintenance Annual Report 2022

In 2021, trail maintenance made a strong comeback from 2020. We had 17 work parties, we covered 85 km of trail, and 616 person-hours were completed by 23 volunteers. In 2020, we had 14 work parties, maintained 45 km of trail, and logged 475 person-hours.

We began the season by re-routing a section of the trail near Kopp Lake due to a lost permission. The VanDalfsen family graciously allowed us to put the new section of trail on their side of the fence. The crew installed a unique double stile to cross an intersection of 4 properties, with permission in 2 opposite quadrants.

Due to a combination of favourable weather and permission from Miquelon Provincial Park, we were able to maintain our trail on the Miquelon Lakes section for the first time in at least 5 years.

The crew completed 13.2 km of trail maintenance in Ministik from A87 to A88. Access to this long section of trail is only available from the trailheads on either end which makes maintaining the middle section a special challenge.

Finally, we were able to re-route a short section of trail in Ministik around the ecologically sensitive muskeg. We thank former Permissions Director Rose Marie Jalbert for helping us obtain authorization for the changes to the trail when she renewed our lease.

In October, we finished the season with our second annual Maintenance Crew hike and picnic at Coal Lake. We thank landowners Lori and Jay Cridland for letting us enjoy their stopover for our smokie roast.

Two generous individuals made donations to maintenance last year. Mitchell Dean of Beaumont gave us two external frame backpacks to help us carry tools and materials into the field. Murray Knight of Morinville donated salvaged lumber and hardware which will help us keep our expenses down this year.

John Scotvold purchased a used self-propelled Ariens lawnmower for \$300 which will help keep our fleet running smoothly in the future.

2021 was Ellen and Sherry's final year as co-directors of maintenance. We would like to thank the crew for their support and their dedication: John S., Brad, John R, Jon S, Gary, Bonnie, Darlene, Helen, Lee, Mike, Elizabeth, Oscar, Johanna, Peggy, Jeff, Maria, Dean, Grant, Mary and Cathy.

Permissions Report AGM 2022

Trail

Over 200 km of the Waskahegan Trail runs across the properties of over a hundred landowners. If not for their generous permission, the trail would not exist.

The role of the Permissions Director is to maintain the contact information of the landowners and to be their main point of contact if they need to reach out to us. The role also includes maintaining our records of who owns what piece of land the trail runs on. Rosemarie Jalbert had this role until she stepped down in April 2021. She had re-confirmed permissions with all the landowners, updated the records, and organized them.

As of April last year, we have not had an official Permissions director so I filled in. Once I learned how to read land descriptions, I found the job easy to do. That's partly because the records are in such fabulous shape, but also because the landowners are generally accommodating. The ones I've had contact with this year support the trail and appreciate what we do.

That's not to say that we don't ever lose permissions. Just before Rosemarie left, access was rescinded on a section of trail at Kopp Lake. Thankfully, a neighboring landowner generously allowed us to reroute on their property, and that was completed this year.

It's because permissions can change at any time that we urge hikers to always check the Trail Conditions page on the website before setting out.

Leases

We lease crown land for 4 properties, and all have come up for renewal in the last few years. Under Rosemarie's tenure, renewal for the Ministik Bird & Game Sanctuary was renewed to 6 October 2045. The remaining three leases are still waiting for processing with Alberta Government

WTA Trail Location Report

Terry Elrod, Director of Trail Location 2022-04-04

The purpose of Trail Location

The purpose of Trail Location is to provide the WTA with accurate and up-to-date documentation of the trail's locations, features and condition. This includes information for every trail segment about:

- The precise route
- The location and state of all trail constructions (bridges, board walks and stiles),
- The location of all landmarks (such at those mentioned in the Trail Guide).
- Other features of interest.

This information is useful for

- Trail maintenance
- Trail scouting
- Landowner relations
- Obtaining lease renewals from government entities
- Supporting revisions to the Trail Guide

Trail Location activity in 2021/2

Trail location activity for reduced for the past year for a few reasons:

- Most of the trail has already been documented, including nearly the entirety of the trail on private land.
- COVID-19 concerns hindered carpooling with Trail Maintenance, which reduces travel costs.
- Due to the financial environment facing the WTA, all travel expense pertaining to Trail Location was donated by its director.

Nevertheless, visits were made to portions of Bigstone Creek, Coal Lake, the Battle River, and Ross Creek. Newly obtained information is in the process of being integrated into other documentation. This will be timed so that Trail Maintenance will have current information about every trail segment before it is maintained in the upcoming 2022 season.

2021 Hike Statistics

- 25 hikes, avg 13 attendees 11.5 members and 1.5 guests
- 67 members and 22 guests attended at least 1 hike (was 52 and 39 in 2020 with same # hikes)
- 20 members attended 4 to 10 hikes, 8 members attended more than 10 hikes

Update on Funding and Casinos

The Board of Directors has reviewed the state of our finances in light of the impacts of the pandemic and our reduced access to casino funding.

What do we spend and how is it funded?

• Funded by Membership Fees and Donations

In 2022-2023 we plan to spend the following:

Membership: mailing, events	\$1,600
Services: website, mailbox, accounting	\$1,100
software	
Other: Landowner communications, volunteer	\$800
expenses, etc.	
Total	\$3,500

Membership fees are projected to be \$3300 and donations \$750 per year. The goal is to spend within our means.

Note: Guidebooks are excluded from the above, since they are produced in bulk on an occasional basis and sold at cost.

Funded by Casino

In 2022-2023 we plan to spend the following on Trail Maintenance:

Equipment and supplies, storage/shop rental,	\$7,900
and mileage -	
Insurance: Commercial, Directors, and WCB -	\$2,100
Leases, First Aid certifications, etc	\$800
Total	\$10,800

These are typical costs except for mileage, equipment, and supplies where we are looking at creative ways to make do with less, especially in light of increased inflation and higher fuel costs.

The Casino bank account is drawn down each year to cover these costs.

What do we have in our bank accounts?

Since 2016, the General account has been around \$20,000. It provides a safe cushion for times when we have extraordinary expenses, such as ordering a bulk volume of guidebooks.

The Casino account, on the other hand, is nearly out of funds.

When are we getting another casino?

During the pandemic, organizations were not able to have casinos. Now there is a large backlog ahead of us, so we are likely to run out of funds before we get our casino.

Fortunately, we can draw on our General account balance to fund Trail Maintenance activities for a limited time.

Unfortunately, Alberta Gaming and Liquor Commission (AGLC) has a new policy about where an organization can hold its casino. They decided that WTA's programs are more outside Edmonton and therefore our casino will be held in Camrose.

This means there is a larger backlog ahead of us than there would be if our casino is in Edmonton, so we will have even more delay than usual.

Furthermore, the share of casino proceeds we are likely to receive will be substantially less than what we are used to receiving.

Conclusion

We are facing a new permanent funding challenge, due largely to a change in casino policy. We won't know the extent of the challenge for some time, while we wait for the backlog of organizations to hold their casinos and then it becomes our turn.

In the meantime, we plan to rely on the General account to fill the funding gap and to continue being creative on managing trail maintenance costs. We will also monitor the situation with AGLC. The Board will be interested to hear any of your thoughts or suggestions.
